

Subj: Small Boat, Recreation, request for;

1. In consideration of the semi-isolated location of the Coast Guard Loran Transmitting Station, it is requested that a boat suitable for fishing be assigned to this unit.
2. This unit is located fifteen (15) miles from the closest town providing any type of recreation except taverns. The majority of the personnel aboard this unit are single, and between the ages of 18 and 23 years of age. It is my belief that if a motor propelled small boat, suitable for fishing in the inland waters is assigned this unit, considerable increase in morale would be noted.
3. I have been informed by local residents of Hobe Sound Fla., who have docking facilities, that this station will be allowed to dock the small boat at any private dock.
4. If a boat is assigned this station, arrangements for transportation from Miami, Fla., to Hobe Sound Fla., can be made providing size and type of boat is known.
