SUBJECT: U.S.-TURKISH DEFENSE COOPERATION: KARGABURUN LORAN

STATION

1. IN RECENT MONTHS, MISSION AND U.S. COAST GUARD ACTIVITIES, EUROPE OFFICERS HAVE DISCUSSED DESIRABILITY/FEASIBILITY OF PHASED PROGRAM TO TURN KARGABURUN LORAN-C STATION OVER TO TURKISH MANAGEMENT. MISSION, AS IS THE COAST GUARD, HAS BEEN CONCERNED OVER DEGRADATION OF LORAN-C COVERAGE IN THE EASTERN MEDITERRANEAN SINCE SUSPENSION OF KARGABURUN OPERATIONS IN JULY 1975, AS WELL AS LONG-TERM MAINTENANCE OF KARGABURUN AS U.S.-OPERATED FACILITY. OUR REVIEW HAS TENTATIVELY CONCLUDED THAT GOT MILITARY OR CIVILIAN AUTHORITIES, WITH TRAINING AND SUPPORT BY THE COAST GUARD OVER A PERIOD TO BE AGREED UPON CONFIDENTIAL

WITH THE GOT, WOULD BE CAPABLE OF OPERATING KARGABURUN TO BOTH U.S. AND TURKISH BENEFIT IN PROVIDING NAVIGATIONAL DATA FOR MARINE TRAFFIC AND AVIATION IN THE EASTERN MEDITERRANEAN. THE TURKS, HOWEVER, DO NOT REPEAT NOT HAVE THE CAPABILITY TO ASSUME CONTROL AND OPERATE KARGABURUN IMMEDIATELY, AND WE WOULD ENVISAGE PERHAPS A ONE TO THREE YEAR TURNOVER PERIOD DEPENDING ON TRAINING AND SUPPORT REQUIREMENTS.

- 2. TO THIS END, WE ASKED COAST GUARD EUROPEAN ACTIVITIES OFFICE TO PROVIDE A TALKING PAPER SPELLING OUT THE POTENTIAL ADVANTAGES TO THE TURKS OF SUCH A TURNOVER AND POSSIBLE ELEMENTS OF A PROGRAM FOR U.S. COAST GUARD TRAINING AND SUPPORT. THESE IDEAS HAVE NOT REPEAT NOT YET BEEN BROACHED WITH THE GOT AND, AT THIS STAGE, WE ARE SEEKING WASHINGTON COMMENTS ON A POSSIBLE TURNOVER PROPOSAL BASED ON THE TALKING PAPER PER TEXT IN PARA-GRAPH 4 BELOW. OUR ASSESSMENT IS THAT SUCH A PROPOSAL MIGHT BE ATTRACTIVE TO THE GOT AND THAT WE COULD INITIATE DISCUSSIONS SOON TO SOUND THE TURKS OUT AND TO OBTAIN AGREEMENT IN PRINCIPLE ON A TURNOVER PLAN. SUBSEQUENTLY, TECHNICAL DISCUSSIONS COULD BE UNDERTAKEN WITH THE GOT TO WORK OUT SPECIFIC ASPECTS OF THE PLAN, INCLUDING TRAINING AND FUNDING REQUIREMENTS. FINALLY, WE BELIEVE THAT DISCUSSION OF THE KARGABURUN TURNOVER PLAN MUST BE PHASED WITH USG ACTION ON THE U.S.-TURKISH DEFENSE COOPERATION AGREEMENT (KARGABURUN STATION IS LISTED AMONG THE FACILITIES IN ARTICLE III (1) OF THE DCA).
- 3. ACTION REQUESTED: WASHINGTON COMMENTS ON THE TALKING PAPER BELOW AND ON THE FEASIBILITY AND TIMING OF INITIATING CONTACTS WITH THE GOT REGARDING THE FUTURE OF KARGABURUN.
- 4. TALKING PAPER: BEGIN TEXT
  IT IS THE DESIRE OF THE U.S. GOVERNMENT TO RETURN THE FACILITY
  AT KARGABURUN TO NORMAL OPERATION. ADVANTAGES ACCRUING TO THE
  CONFIDENTIAL.

GOVERNMENT OF TURKEY BY PERMITTING FULL OPERATION ARE MANY:

## AS EXAMPLES:

- 1. PERMITTING ACCURATE SURVEYS AND REPEATABLE POSITION INFORMATION IN THE CURRENT PETROLEUM EXPLORATION AND FUTURE EXPLOITATION OF DISCOVERIES ON THE TURKISH CONTINENTAL SHELF.
- 2. AS A POSITIONING AID IN FUTURE SEABED MINING.
- 3. TO PROVIDE UNIVERSAL TIME DATA FOR SCIENTIFIC AND TECHNOLOGICAL PROGRAM IN TURKEY, INCLUDING THE NATIONAL OBSERVATORY. AN INTERESTING POSSIBLE APPLICATION WOULD BE REAL-TIME CONTROL OF MARINE TRAFFIC IN THE BOSPHORUS AND DARDANELLES.
  4. TO PROVIDE NAVIGATIONAL DATA FOR FUTURE EXPANSION/MODERNIZATION OF TURKISH MERCHANT SHIPPING, COMMERCIAL FISHERIES AND CIVIL AVIATION.

LACK OF THIS FACILITY HAS PRESENTED PROBLEMS TO THE SHIPPING AND CIVIL AVIATION INTERESTS OF NATO ALLIES OPERATING IN THE EASTERN MEDITERRANEAN. THE U.S. GOVERNMENT THEREFORE WISHES TO ADVANCE THE FOLLOWING PROPOSALS:

THAT THE NAVIGATIONAL FACILITY AT KARGABURUN BE PERMITTED TO RETURN TO NORMAL OPERATION.

THAT U.S. COAST GUARD PERSONNEL WOULD BE WITHDRAWN AND THE OPERATION TURNED OVER TO TURKISH PERSONNEL FOR HOST NATION OPERATION IN THE MANNER WHICH HAS WORKED SUCCESSFULLY FOR YEARS WITH THE GOVERNMENTS OF NORWAY, DENMARK, ICELAND AND CANADA.

THAT THE TURKISH PERSONNEL AS SPECIFIED BY THE GOVERNMENT OF TURKEY BE TRAINED BY THE U.S. GOVERNMENT IN THE OPERATIONAND MAINTENANCE OF THE TRANSMITTING, TIMING, SWITCHING, POWER GENERATION, ENVIRONMENTAL CONTROL AND PERIPHERAL EQUIPMENT INSTALLED AT THE KARGABURUN FACILITY.

THAT THE FULL OPERATION OF THE FACILITY BE ASSUMED BY THE GOVERNMENT OF TURKEY AT THE TIME SUFFICIENT TRAINED TURKISH CONFIDENTIAL
