TASK ORGANIZATION: Annex A.

1. SITUATION:

- a. LORAN Station (LORSTA) Havre, Montana is scheduled to become operational in January 1991 as part of the Mid-Continent Loran-C Expansion Project.
- b. LORSTA Havre is the Master station of the North Central
 U. S. (NOCUS) Loran-C chain (rate 8290).

2. MISSION:

Establish LORSTA Havre in accordance with references (a)-(c).

EXECUTION:

- a. Concept of Operations.
- (1) LORSTA Havre will be under the operational control of Commander, Pacific Area (Ptl), and the Coordinator of Chain Operations (COCO) of the North Central U. S. Loran-C chain.
- (2) Commander, Thirteenth Coast Guard District will have administrative control.
- (3) Reference (a) designates Commander, Pacific Area as the Regional Manager (RM) and Chain Manager (CM) of the North Central U. S. Loran-C chain. Specific responsibilities of the RM and CM are covered in COMDTINST M16500.13, Aids to Navigation Manual, Radionavigation.
- (4) Shore Maintenance Detachment (SMD) Alameda, CA will provide engineering support for LORSTA Havre in accordance with reference (a).

3.a.(5) Maintenance and Logistics Command Pacific (MLCPAC) will provide field support for LORSTA Havre in accordance with reference (a).

b. Tasking.

- (1) Commander, Thirteenth Coast Guard District will:
 - a. Coordinate all press releases related to establishment of LORSTA Havre.
 - b. Administer LORSTA Havre pre-commissioning funds.
 - Coordinate unit requirements with Headquarters, PACAREA and MLCPAC.
 - d. Request vehicle issue from GSA Supply Center Billings, Montana.
 - e. Establish a Morale Fund for LORSTA Havre.
- (2) Pre-commissioning Detail/LORSTA Havre will:
 - a. Inventory all installed and spare electronic equipment to establish an initial Electronic Installation Record (EIR). Report this data per instructions for the Electronic Equipment Information System (EEIS) contained in the Electronics Manual (COMDTINST M10550.25).
 - b. Submit an initial SORTS IAW COMDTINST M3501.2E and NWP 10-1-11 (REV.A).
 - c. Ensure that the Ship Parts Control Center (SPCC), Mechanicsburg, PA, is included on station CASREPs.
 - d. Request start up morale, welfare and recreation funding.
 - e. Conduct a suitable ceremony marking the establishment of LORSTA Havre. Specific date and details of the ceremony will be coordinated with CCGD13 (oan) in accordance with reference (a).

4. ADMINISTRATION AND LOGISTICS:

- a. The pre-commissioning detail will use the same Operating Facility (OPFAC) number and activity address code that has been assigned to LORSTA Havre. See Annex B.
