#### LORAN-C Station Havre History

In the early 1960's, Congress authorized the operation of a network of navigation stations known as LORAN-C (Long Range Navigation). The system was designed to replace an aging and less accurate aid to navigation system. LORAN-C is capable of providing accurate position fixing within ¼ mile. LORAN-C systems are used by civilian and military vessels and aircraft.

The Coast Guard LORAN station at Havre, Montana was built in 1991 by Coleman Construction Company of Spokane, Washington. The Station began transmitting its prescribed signal on January 29, 1991. When the station started operation, it covered gaps in the Loran C coverage in the mid-continent and was used to free up crowded air traffic lanes by allowing air craft to fly direct routes.

The station transmits signal at 100KHz, at a radiated output power of 400 kilowatts. Station Havre rate (8290). The coverage area for this chain stretches most of the north central United States and parts of southern Canada.

#### The Ceremony

The change of command Ceremony is a time-honored tradition, which formally restates to the officers and crew the continuity of the authority of command. The occasion ensures that all hands know of the shift in authority, and that a duly authorized officer is placed in charge.

Deeply rooted in U.S. Coast Guard history, this formal ritual is unique among the armed forces and publicly underscores the distinctive nature of command in the U.S. Coast Guard. It signifies the total transfer of responsibility, authority and accountability for the command.

It marks the end of a segment of the command's history, but most importantly, it signals a new beginning, a new opportunity for even greater achievements in the future.
