1. In accordance with reference (a), I hereby report resumption of regular duty by Lt. (j.g.) D. R. Rodgers as Commanding Officer of USCG Loran Radio Station at Port Aux Basques, Newfoundland as directed by ComNorLantPat Order No. 730323.

2. Transfer of command has been accomplished after a thorough inspection of the station. The crew was exercised at fire drill with satisfactory performance. Copies of all general regulations in force and all pertinent official correspondence concerning the unit have been delivered to the relieving officer. Registered publications have been inspected, and all such effective publications on custody receipt to this unit are on hand. An inventory of small arms was taken and found to agree completely with that inventory given in reference (c). Commissary stores on hand have been inventoried and the value thereof established as \$506.07, this date. According to commissary reports to be submitted, the station mess shows a deficit of \$209.77 as of 31 March, 1947.

3. The personnel and material conditions of the unit are essentially the same as outlined in reference (c), and material deficiencies described in NavCG-2855, December, 1946, still exist. As mentioned in reference (c), a pharmacist's mate is urgently needed.
