OPERATION ORDER

CCGDFOURTEEN NO. 06-81 (PHASEOUT LORMONSTA SAIPAN/ESTABLISH CG DETACHMENT SAIPAN)

Ref: (a) Commandant ltr 11010 of 21 January 1981

Time Zone: Use time zone India (+9) for all evolutions.

Task Organization:

- a. Staff, Fourteenth Coast Guard District
 - b. Commander, Coast Guard Section Far East
 - c. Commander, Coast Guard Section Marianas
 - d. Commanding Officer, CG Loran Monitor Station Saipan
1. Situation: Reference (a) is Commandant's approval of a planning proposal to establish Detachment Saipan as a subunit of MARSEC and to disestablish LORMONSTA Saipan.
 2. Mission: To establish Detachment Saipan as a subunit of MARSEC with concurrent phaseout of the NWPAC Loran-C Monitor control function at Saipan through installation and correlation of LORMONSITE Guam.
 3. Execution: Implementation of this monitor automation/establishment shall be effected with specific tasks performed by the following:
 - a. Commander, Coast Guard Section Far East:
 - (1) Coordinate with Chief, Electronics Engineering Branch, CCGD14, concerning disposition action on all electronics equipment at LORMONSTA Saipan.
 - (2) Coordinate with Chief, Electronics Engineering Branch concerning certification and correlation of LORMONSITE Guam.
 - (3) Develop and maintain schedule for site preparation and equipment installation/deinstallation necessary for execution of this OPORDER.
 - (4) Upon successful certification, establish LORMONSITE Guam as a subunit of Commander, Far East Section.

b. Commander, Coast Guard Section Marianas:

- (1) Coordinate all aspects of the establishment of Detachment Saipan as a subunit of MARSEC.
- (2) Initiate Board of Survey action and recommended disposition on all personal property and items of electronic equipment designated by CCGD14(eee).
- (3) Coordinate with AAFES for closure of the satellite exchange at LORMONSTA Saipan.
- (4) Coordinate the removal of NWS meteorological equipment and termination of weather observations with the appropriate NWS command.
- (5) Assist LORMONSTA Saipan with the transfer of personal property to off-island organizations.

c. Staff, 14th Coast Guard District:

(1) Chief, Operations Division:

- (a) Oversee all aspects of this OPORDER, coordinate the activities of other commands and staff components, keep CCGD14 advised as to the status of execution, and arrange for exchange of necessary information between CCGD14, Commandant, U. S. Coast Guard and Commander, U. S. Coast Guard Pacific Area.
- (b) Coordinate with Saipan, as applicable, the disposition of classified material, ordnance material, RADIACS and any other related material not to be transferred to the Detachment Saipan function.
- (c) Reassign duties and responsibilities now being performed on a collateral basis by LORMONSTA Saipan.

(2) Chief, Engineering Division:

- (a) Prepare lists of electronic, power generating, and other equipment and tools which should be removed from the station, determine the disposition of this equipment, and advise MARSEC and LORMONSTA Saipan of transportation requirements.

(3) Chief, Personnel Division:

- (a) Coordinate with Commandant, Far East Section, Marianas Section and LORMONSTA Saipan the transfer and rotation of USCG personnel assigned to the LORMONSTA and advise MARSEC of travel requirements for personnel leaving the station.
- (b) Arrange for disestablishment of morale funds and other activities under cognizance of the Personnel Division.

(4) Chief, Comptroller Division:

- (a) Coordinate budget and allocation adjustments indicated by the disestablishment of LORMONSTA Saipan and establishment of Detachment Saipan.
- (b) Direct, advise, and assist as necessary, the disestablishment or cancelling of funds, accounts and authorization under the cognizance of the Comptroller Division.
- (c) Arrange for a Board of Survey for non-electronic real property at LORMONSTA Saipan.

(5) Chief, Public Affairs Branch:

- (a) When advised by CCGD14 that release is authorized, make appropriate press releases covering the disestablishment of the LORMONSTA and establishment of Detachment Saipan.

d. Commanding Officer, CG LORMONSTA Saipan:

- (1) Maintain local liaison regarding all phases of the disestablishment of the LORMONSTA.
- (2) Beginning 1 May 1981 submit bi-weekly SITREPs to CCGD14(o) as applicable. After 1 June 1981 increase frequency of SITREPs to weekly.
- (3) Maintain reliable loran monitor service until termination of loran monitor functions is directed by CCGD14.
- (4) Decommission LORMONSTA Saipan in accordance with USCG regulations and other pertinent directives.
- (5) Advise Commandant (G-NRN) by message of effective date of disestablishment of unit.



- (6) Disestablish general mess subsequent to an orderly drawdown of stores. Initiate Board of Survey for stores items at time of general mess disestablishment.
 - (7) Arrange for transportation of all property to be transferred off island.
 - (8) Submit final form CCGD14-269C effective date of disestablishment. Annotate this form with "FINAL" and the certification statement in accordance with paragraph 6, Section I, part J, Comptroller Supplement to Annex Q, CCGD14 OPLAN.
 - (9) Submit form CG-4183, Change of Mailing, Freight and Billing Address via CCGD14(flp) 30 days in advance of disestablishment.
4. Administration and Logistics: Normal USCG administrative and logistic channels and procedures will apply.
- a. In order to keep track of all costs associated with this OPORDER (except PCS), the following procedures will apply.
 - (1) Unit OG-30 costs: LORMONSTA Saipan shall establish a separate project number(s) on its Unit Financial Management Plan to account for all costs associated with this OPORDER. Obligations incurred as a result of this OPORDER shall be recorded under this project number(s).
 - (2) All other costs: LORMONSTA Saipan shall provide one copy of the applicable document (as indicated in the draft OPORDER) to (fbr) vice (fac).
