COMMENTS: Adak is another semi-restricted station. Half the crew live on board and the other half live in Navy housing fifteen miles from the unit. This latter group consists of mainly the higher rated men. They are not immediately available for recall to the station. Several changes are proposed to compensate for the problem of this residence factor. Teletype repair services can be contracted from the Navy at Adak. It is recommended the TT3 billet be converted to an ET3 billet. Adak mans a continuous one watch radio position. An additional RM3 should be assigned for this duty. The services of both a YN and SK are not required. Deletion of the YN2 billet is requested. Addition of another EN3 is requested to provide for an engineman to be on the station at all times. The assignment of four seamen to this station seems excessive and it is recommended the allowance be reduced to three (3). 23


