- In conjunction with the change of command at LORAN Station Attu, the requirements of reference (a) have been met. References (b) and (c) will be of further reference for your use.
- 2. The station's personnel strength is at full allowance level; one (1) officer and nineteen (19) enlisted billets. The present compliment is matched with the Personnel Allowance List (PAL). Training levels of all personnel assigned are sufficient to support the mission. All rates assigned have proper qualification codes. Crew morale is high. No pay problems are noted. There are no mishap cases pending.

3. CASREPs Pending:

- a. 06011 LORAN TOWER GROUND RADIAL SYSTEM. Repair is pending good weather. All parts are on station to complete repairs.
- 4. There are no classified documents on board the unit. All accountable materials are present and all classified material accountability systems were found to be in good order. A change in Command Security Officer (CSO) and remote Cryptographic Materials System (CMS) Use has been effected via separate correspondence.
- All narcotics and controlled substances were inventoried. There were no discrepancies.
 Relief of custodial responsibility has been effected via separate correspondence.
- There are no service weapons on board. All morale weapons were inventoried and inspected. All weapons were accounted for.
- A random card check of the commissary was conducted with no discrepancies noted. A
 complete inventory of the commissary was not required because CWO3 Bower is not
 relieving as Food Services Officer.

- All End of Course Tests and CLEP Tests were inventoried with no discrepancies noted. The unit's designation as a DANTES Test Control Center has been suspended pending assignment of a Permanent Testing Control Officer. The CG Institute and DOD Voluntary Education programs have been contacted and advise that Attu can be designated as an Information Only Site. ISC Kodiak's ESO, Gary Dorman, can administer future DANTES exams to ensure no break in crew educational pursuits.
- CWO3 Bower reviewed the unit OPTAR records. The following is a summary for the AFC-30 ledger:

- 10. CWO3 Bower has examined the records and accounts of the Morale Fund and found them to be in order.
- 11. An audit of the unit's CG Satellite Exchange was conducted, no discrepancies were noted.
- 12. Station engineering personnel continue to perform all maintenance on and dispense fuel to all unit vehicles due to the absence of commercial resources.
- 13. Diesel and gas fuel quantities on hand are sufficient to supply the unit through March 2009. A fuel barge is scheduled to arrive late summer 2008.
- 14. The material condition of the exterior and interior spaces are in fair to good condition, with various safety, code, and habitability discrepancies noted. The majority of the discrepancies will be completed this summer during the station rehabilitation project.
- 15. CWO3 Bower is fully aware of all station projects, material conditions, and personnel status. He has signed all pertinent letters of designation and has assumed custody of all accountable materials and station funds.
- There are no facts in dispute.
- 17. CWO3 Bower will relieve me as Commanding Officer of U.S. Coast Guard LORAN Station Attu effective 1500, 25 June 2008.
