OPERATION ORDER  
CCGDFIVE NO. 04-81

- Ref: (a) COMDT COGARD OFCO NO. 26-80 dated 19 March 1980  
 (b) COMDT (G-WAN-3/73) ltr 16561.1/7A dtd 8 January 1979  
 (c) CCGDFIVE (eee) ltr 16561 dtd 2 June 1980

Time Zone: Use Romeo (+5) time for all operations.

Task Organization:

- a. Commander, Fifth Coast Guard District.
- b. Commander, Coast Guard Group Cape Hatteras, NC.
- c. Officer-in-Charge, Coast Guard LORAN-A Station, Cape Hatteras, NC.
- d. Officer-in-Charge, Coast Guard EST Cape Hatteras, NC.

1. Situation: Reference (a) authorizes the termination of LORAN-A signals at 1900, 31 December 1980 and the disestablishment of LORAN Station Cape Hatteras as soon as practicable thereafter.

2. Mission: To coordinate and execute a smooth and orderly disestablishment of LORAN-A Station Cape Hatteras, NC.

3. Execution:

- a. Commander, Fifth Coast Guard District (oan): Exercise overall control and provide guidance as required.
- b. Commander, Fifth Coast Guard District (dpl):
  - 1. Prepare necessary environmental documents.
  - 2. Determine disposition of PCB's and provide CCGDFIVE (flp) with authorized disposal areas.
- c. Commander, Fifth Coast Guard District (p): Coordinate the transfer of personnel. Billet reductions will be in accordance with the guidelines set forth in reference (b). *MOSTLY DONE*
- d. Commander, Fifth Coast Guard District (flp): Provide guidelines for disposition of real/plant property and excess equipment, spare parts or materials suspected of containing PCB's.

- e. Commander, Fifth Coast Guard District (dpa): Issue appropriate press release.
- f. Commander, Fifth Coast Guard District (ecv): Arrange for the dismantlement and disposal of LORAN-A transmitting antenna towers and associated hardware.
- g. Commander, Fifth Coast Guard District (eee): Assist in determining what electronic equipment and electronic spare parts are suspected of containing PCB's.
- h. Commander, Coast Guard Group Cape Hatteras, NC:
1. Provide necessary support to LORAN Station Cape Hatteras to carry out this OORDER.
  2. Arrange for shipping of materials in accordance with reference (c) and as directed by CCGDFIVE (flp) under separate correspondence.
  3. Coordinate with CCGDFIVE (p) for a firm date to transfer personnel.
  4. Assume the responsibilities presently assigned LORAN Station Cape Hatteras for monitoring CAPE HATTERAS LIGHT (LLNR 167).
  5. Advise CCGDFIVE (oan) by priority message as soon as disestablishment is completed.
- i. Officer-in-Charge, LORAN-A Station Cape Hatteras, NC:

1. Submit Form CG-4183, change of mailing, freight and billing address on or before 1 December 1980.
  2. Dispose of all electronics equipment and spare parts containing Polychlorinated Biphenyls (PCB's) as directed by CCGDFIVE (flp). Dispose of all other electronic equipment as directed in reference (c). All publications, directives and technical manuals pertaining to a piece of equipment should be destroyed or transferred with the equipment.
  3. Secure LORAN-A transmissions at 1900 31 December 1980. Advise CCGDFIVE (oan) by priority message.
  4. Dispose of excess property as directed by CCGDFIVE (flp) to be issued under separate correspondence.
  5. Dispose of unit files in accordance with CG-416. Direct communication with the Federal Records Center is authorized.
- j. Officer-in-Charge EST Cape Hatteras: Assume custody of all properties presently assigned LORAN Station Cape Hatteras, including buildings, grounds and other equipment not otherwise covered in this OORDER.


