1. COMMAND:

- a. The Unit Organization Manual was promulgated on 1 June 1979. It is considered well written and sets forth the mission of the unit.

 - d. UCMJ poster is clearly displayed in crew's recreation area.
 - e. Safety program is excellent.

2. PERSONNEL:

- a. Personnel are familiar with the Coast Guard Mutual Assistance Program and the services it provides.
- b. The overall administration of the unit is outstanding. The unit maintains 12 service records with one SK2. ID cards and vehicle registration stickers are issued by MSO Wilmington. The SK2 is doing an outstanding job in maintaining the service records.
 - c. Health records are being properly maintained.
- d. The Unit Punishment Book is maintained in excellent condition. A total of 4 NJP's were conducted during the past twelve months. Of the total 1 of the accused were minority personnel.
